This show will be held under the Rules and Regulations of the Kennel Union of Southern Africa. Conditions attracting immediate disqualification are set out in Regulations 7 & 31 of Schedule 3.

All Exhibitors/Handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs. All exhibits must be on leads at all times unless otherwise instructed by a Judge. The mating of bitches within the precincts of the show is forbidden. No entries with RAF or TAF will be accepted. Bitches in season will be permitted to compete in Breed Classes only. The Committee reserves the right to appoint alternative judges at its discretion.
