DIRECTIONS FROM CAPE TOWN: Take the N1 towards Stellenbosch. Take the Stellenbosch/Wellington/Klapmuts R44 offramp (Exit 47). Turn onto the R44 to Wellington. After +/- 100m, you will see a sign for Protea Road. Turn left & follow the road for just over a km and you will see the show grounds on your left.

DIRECTIONS FROM STELLENBOSCH: Take the R44 towards the N1 and Paarl. Just past the Butterfly World, go under the N1 and after about 100m you will see a sign for Protea Road, turn left and follow the road for just over a kilometre and you will see the show grounds on your left.



"All exhibitors are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs." The mating of bitches within the precincts of the Show is forbidden. Puppies under four (4) months are not eligible for competition. The committee reserves the right to appoint other judges. Championship Show: The committee reserves the right to withdraw judging contracts and to combine groups. All dogs are to be kept on leash at all times. Conditions attracting immediate disqualification are set out in Reg. 4 of Schedule 4 and Reg. 31 of Schedule. **Only Members of the Kennel Union of Southern Africa shall be entitled to enter dogs in their registered ownership in any Championship Dog Show licensed by the Kennel Union.
