JUNIOR HANDLERS: FROM 11 - UNDER 18 YEARS OF AGE BEFORE THE DAY OF THE NATIONAL FINALS

Dog`s records must be presented to the judge before competing in the respective grades.

NOTE:

- Bitches in season are permitted to compete in all Breed classes, Dog Jumping and Agility grades only.
- The mating of bitches in the precincts of the show is forbidden. Conditions attracting immediate disqualification are set out on Regulations 7&31 of Schedule 3
- Only members of the Kennel Union shall be entitled to enter dogs in their registered ownership in any Championship Dog Show licensed by the Kennel Union.

All exhibitors/handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs.

RIGHT OF ADMISSION IS RESERVED – NO CARS ALLOWED ON FIELDS
