A dog is not eligible for entry in variety classes unless also entered and exhibited in a breed class, except a veteran, which may be entered in any Variety Veteran Class. (Schedule 3 Regulation 5)

Floating Trophy for Miniature Long-haired Dachshunds Best of Breed winner.

Bitches in season are allowed for exhibition.
