ACCESS

Access to this event will only be allowed through a single gate on HF Verwoerd Road.

An Access Control Point will be set up at the gate, which will be manned for the entire duration of the event.

and hand in a completed and signed Disclaimer form,

after which they will be allowed access to the venue.

NO access will be allowed without the above.

- NO ENTRIES will be accepted if the correct entry fee does not accompany them. No entries with RAF or TAF on them will be accepted.
- This Show will be conducted under KUSA Rules and Regulations. Exhibitors/handlers are responsible for the control of their dogs and shall be personally liable for claims for injuries/damages caused by their dogs.
- Bitches in season are permitted to enter this show, but consideration must be shown to other exhibitors.
- The Judge will select competitors for the BEST HEAD, BEST MOVER and BEST COLOURED challenge classes from the Breed classes during the course of the show. Final judging of these special classes will be done after the judging of the Best in Show exhibit.
- Kindly note that the Club reserves the right to appoint an alternative Judge should the nominated Judge be unable to officiate.
- Save for the Breed Classes offered at Specialist Club Championship Shows, all dogs entered and exhibited at Championship Shows must be registered in the ownership of members of the Kennel Union.
- All dogs to be present on the Show Grounds at least 30 minutes prior to start of the Show
- Please use the latest Official KUSA Show entry form of 01.01.2021
- Puppies under the age of 4 months are not eligible for exhibition
- Mating of bitches in the precincts of the show is forbidden
- Exhibits must be on leads at all times
- No animal other than an exhibit entered in the show is to be on the grounds
- Conditions attracting immediate disqualification may be found in Schedule 3, Regulation 7 & 31
