*The committee reserves the right to appoint alternative judge/s if necessary*All exhibitors/handlers are responsible for the control of their dogs at all times and shall be personally liable for any claims which may arise in respect of any injuries which may arise or be caused by their dogs. All dogs must be kept on leads at ALL times*Bitches in season are allowed but due consideration by handlers to consider other dogs in the ring and surrounds*The mating of bitches within the precincts of the show is forbidden*Conditions attracting immediate disqualification are set out in Reg7&31 of Sched3 of the KUSA Constitution

*Puppies under 4 months of age are not eligible for exhibition nor are allowed on the grounds or precincts of the show.

PLEASE! DO NOT attach the first page of the entry form i.e.the page listing all the classes definitions. Submit only the actual Entry Form."
ONLY the latest Official KUSA show entry form dated 01.01.2022 may be used. Kindly ensure that when updating the entry form that the correct Registration number is inserted for the relevant dog entered. Text messages in the email are not acceptable.
*ONLY members of the KUSA shall be entitled to enter dogs in their registered ownership in any Championship dog show licensed by KUSA.

FEES :

- BREED - R130 dog per class.
- R100 Baby Puppy
- Child/Junior Handlers FREE dog is entered in a breed class.
- Catalogues – R70 Catalogue . To be paid for with entries.
No catalogues will be sold on the day of the Show.

PLEASE NOTE:

- Proof of payment must be sent **WITH** the entry/ies.
- Ensure that entry forms are clearly marked with the relevant CLUB NAME and SHOW DATE
- Entries are **only valid when correct information is on the entry form and POP** have been received.
- Exhibit numbers will not be mailed.
- Entries will be acknowledged in order of email received.
- No unregistered dogs entry will be accepted.
- Do not send payment for unregistered dogs.
- status of dog on closing date will apply and cannot be changed once capture.
- **No class changes may be made once submitted unless the dog is entered into an incorrect restricted class.**
- If no class has been specified the dog will be entered into the OPEN class.
- If no sex has been specified on the entry form the dog will be entered as a DOG.
- **Only HARDCOPIES** of pop and entry form will be accepted for clarification on the day. No cell phone entries will be accepted.

BREED CLASSES

Baby Puppy, Minor Puppy, Puppy, Junior, Graduate, Veteran, SA Bred, Open, Champion, Neuter.

ORDER OF JUDGING

BREED – BOB; BP; BJ; BV; SAB then Baby Puppy and Neuter.

BISs – BP; BN; BJ; BV; BSAB; BP; BIS.

Current COVID-19 Protocols & Procedures will be observed at this event.

- A maximum of 2000 people will be allowed at the venue at any one time if held outdoors, or 750 attendees if held indoors.
- All persons attending this event must wear a reusable cloth or sponge face mask, or a disposable surgical mask, except while handling/running a dog in competition in the ring. Face shields only are not legal. Any person not wearing a mask will be requested to leave the venue.
- All attendees must observe social distancing and, whenever feasible maintain a distance of at least 1.5 metres between themselves and others with whom they don't cohabit.
- Sanitisers will be available at the Organisers's Office, on all Judges' table, at ring entrances and in the toilet areas.
- Please note that by entering and/or attending this event, participants are agreeing to comply with any instructions issued by the COVID-19 Compliance Officers, and that the Organisers have the right to request any person who refuses to comply with a request or instruction to leave the venue.
- Any person found to be non-compliant may also be liable for disciplinary action under Schedule 1 of the KUSA Constitution.
