Breed Classes:	Baby Puppy (4-6 m) Minor Puppy (6-9 m), Puppy (9-12 m), Junior (12-18 m), Graduate (18-24 m), SA Bred, Veteran, Open and Champion. (Baby Puppy not eligible for CC or BOB).		
Challenges: Order of Judging:	Best in Show, Best Baby Puppy, Best Puppy, Best Junior and Best Veteran. On completion of all Breed classes (except Baby Puppy), Best of Breed and Reserve Best of Breed will be judged first, followed by Best Puppy, Best Junior and Best Veteran. Thereafter Baby Puppy Dog & Bitch classes will be judged, followed by Best Baby Puppy.		
Order of BIS judging:	On completion of all Breeds Best in Show will be judged first, followed by Best Puppy, Best Junior, Best Veteran and Best Baby Puppy.		
Catering:	Refreshments will be available.		
General:	 All exhibitors/ Handlers are personally responsible for the control of their dogs and shall be personally liable for any claims which may be made in respect of injury which may arise or be caused by their dogs. This show is held under the Rules & Regulations of the Kennel Union of Southern Africa. No RAF or TAP entries will be accepted. 		
	 Any dog/ bitch entered in the incorrect age group class or the entry not specifying a class will be entered in the open class. Puppies under 4 months are not eligible for exhibition. Bitches in Season will be permitted. The mating of Bitches within the precincts of the Show is forbidden. Exhibits to be on leads at all times unless otherwise instructed by the Judge. The Committee reserves the right to appoint a new judge should the contracted judge be unable to officiate. No animal other than an exhibit entered for competition or exhibition shall be allowed on the grounds with the exception of registered guide dogs. Conditions attracting immediate disqualification are set out in Schedule 3, Regulations 7 & 31.

RIGHT OF ADMISSION RESERVED

Our Right of Admission Reserved is based on our right of "Freedom of Association" as enshrined in Section 18 of the Constitution, insofar as members of the public and even KUSA's own members fail to adhere to the general principles of good order, acceptable behaviour and social decorum customarily required at dog shows. This is likely to include people who are rowdy, drunk, naked, loud or obscene, or who engage in physical violence and/or verbal abuse of other members of the public and of KUSA, or who play loud music or engage in any behaviour that prohibits or limits KUSA and its members from participating in their chosen activity unhindered. In a nutshell, Right of Admission Reserved would sanction the denial of access to, or expulsion from, the premises of persons who indulge in unacceptable conduct and behaviour and who disrupt the good order and social discipline required at dog shows.
