The Show Committee reserves the right to appoint alternative judge should the appointed judge be unable to officiate. Should the judging time be changed all exhibits will be notified.

No animal other than an exhibit enterd for competition or exhibition shall be allowed on the grounds with the exception of registered guide dogs.

ALL EXHIBITORS ARE PERSONALLY RESPONSIBLE FOR THE CONTROL OF THEIR DOGS AT ALL TIMES AND SHALL BE LIABLE FOR ANY CLAIMS IN RESPECT OF INJURIES OR DAMAGE WHICH MAY BE CAUSED BY THEIR DOGS.RIGHT OF ADMISSION RESERVED.
