DOG JUMPING

Bitches in season are allowed to compete in Breed, Agility and Dog Jumping only.

Qualifying cards must be produced prior to entering the ring.

The Club reserves the right to appoint alternate Judges should any of the above be unable to officiate or received too many entries. No RAF or TAF dogs will be accepted. Any incomplete or illegible entries, or those accompanied by incorrect Entry Fees, will be returned. Any dog entered incorrectly will automatically be entered in the Open Class. No changes will be made at the Show.

THIS SHOW WILL BE HELD UNDER THE RULES AND REGULATIONS OF THE KENNEL UNION OF SOUTHERN AFRICA.

All Exhibitors/Handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries caused by their dogs.

Only Members of the Kennel Union shall be entitled to enter dogs in their registered ownership in any Championship Dog Show licensed by the Kennel Union.

Puppies under 4 months are not eligible for exhibition.

The mating of bitches within the precincts of the Show is forbidden.

Conditions attracting immediate disqualification are set out in Schedule 3 Regulations 7 & 31.
