- Exhibits will be marked absent if called 3 times.
- Please note that unless stated to the contrary, all Breeds will be judged in alphabetical order as listed in Appendix A of Schedule 2 of the KUSA Constitution.
- NO REFUNDS for incorrect submission of entry fees and/or for any errors whatsoever made by the Owner/Exhibitor. Breed entries received with no sex specified will be entered as a DOG and Breed entries received with no class specified will be entered in the OPEN Class. Entries only accepted via Show Assist or on the current official KUSA Entry form (v. 01.01.2022)
- The Show Committee reserves the right to appoint alternative judges, re-allocate breeds and advise all exhibits entered, of an earlier judging time, should the appointed judges be unable to officiate or receive too large or too small an entry.
- Dogs travelling from a region infected with Rabies are required to have a valid inoculation certificate against Rabies.
- Bitches in season will be permitted for Breed Classes.
- Exhibitor numbers can be collected from the Show Office before the commencement of the Show.
- Sufficient parking has been provided no vehicles will be allowed within the designated show area. Unhitched trailers will be allowed to be pushed in. PARKING AT OWNERS RISK.
- All exhibitors, handlers & owners are advised that they and any exhibit entered in this event may be photographed for, by or on behalf of PTAKC for the use and possible publication.
- The mating or whelping of bitches within the precincts of the shows is forbidden.
- No animal other than an exhibit entered for competition or exhibition shall be allowed on the grounds, with the exception of registered Guide Dogs.

INTRODUCING SOUTH AFRICA'S FIRST EVER FCI A20 CHAMPIONSHIP SHOW !! DOUBLE AWARDS AT THIS SHOW – A20 CACS UP FOR GRABS !!

Many FCI countries have been awarding "Regional Titles" to dogs which have met the requirements for them to achieve the specific Title. With the diminishing number of entries worldwide, many countries and Sections have found ways and means to attract more exhibitors to enter their Shows and "Titles at stake" play a major part in enticing more entries to join the Shows. South Africa (KUSA) belongs to the Asia, Africa & Oceania (A2O) Section of the FCI. The creation of the Asia, Africa & Oceania (A2O) Champion further promotes our dog shows and Pretoria KC is extremely proud and excited to bring this new A2O Champion Title to South African dog show exhibitors, encouraging further participation at the highest level!!

FCI A2O Championship Shows (A2OCS) are offered in conjunction with Club Championship Shows, and offer, in addition to the KUSA Awards on offer at a KUSA All-Breed Club Championship Shows, the awarding of A2OCS CAC. The A2OCS CAC is to be awarded to the Best Dog & Best Bitch OR Dog CAC & Bitch CAC. This Show is organised according to the rules of the KUSA and the awarding of the A2OCS CAC will follow the rules of the KUSA with regards to the awarding of the Best Dog & Best Bitch OR Dog CAC & Bitch CAC (See Schedule 03B – currently in gestation).

To attain the title Asia, Africa & Oceania Champion, a dog or bitch who is already a South African Champion, or Champion of an FCI member country, must win four (4) A2O Certificates CAC, at any A2O Championship Show organised by any of the KUSA-approved All-Breeds Clubs in any of the Areas of Jurisdiction of KUSA's six (6) Provincial Councils.

- * To attain the title of Asia, Africa & Oceania Grand Champion, a dog or bitch who is already a South African Champion, or Champion of an FCI member country, must win eight (8) A2O Certificates CAC, at any A2O Championship Show organised by any of the KUSA-approved All-breeds Clubs in any of the Areas of Jurisdiction of KUSA's six (6) Provincial Councils, provided that the eight (8) CACs would have been attained, in any contributing quantity, in at least two (2) different Provincial Council Areas of Jurisdiction.
- ** To attain the title of Asia, Africa & Oceania Supreme Champion, a dog or bitch who is already a South African Champion, or Champion of an FCI member country, must win twelve (12) A2O Certificates CAC, at any A2O Championship Show organised by any of the KUSA-approved All-breeds Clubs in any of the Areas of Jurisdiction of KUSA's six (6) Provincial Councils, provided that the twelve (12) CACs would have been attained, in any contributing quantity, in at least three (3) different Provincial Council Areas of Jurisdiction, and must also win at least one (1) Best in Show at an A2O Championship Show.
- * With regard to the Grand Champion & Supreme Champion titles, dispensation has been accorded to South Africa, given South Africa's geographical remoteness and the quarantine restriction that are in place for the movement of livestock.

Whilst the dog has to be a South African (KUSA) Champion or an FCI Country Champion prior to applying for the A2O Champion Certificate (with the proof of the 4 CAC won in accordance with the regulations), that dog does not have to be a Champion prior to entering and receiving its first CAC. A2O CACs can be competed for and "banked" until such time that it is a registered as a South African (KUSA) Champion and can then apply for the A2O Champion Certificate with proof of 4 A2O CACs awarded and the KUSA SA Champion Certificate.
