*Baby Puppy, Minor Puppy, Puppy, Junior, Graduate, Veteran, SA Bred, Open, Champion. * Baby Puppy not eligible for CC or BOB <u>ORDER OF JUDGING</u> BREED – BOB, BP, BJ, BV,BBP GROUPS – BBP, BOB, BP, BJ, BV.

BEST IN SHOWS – BBP, BIS, BP, BJ, BV.

CONDITIONS OF ACCEPTANCE OF ENTRIES

- Submit ONLY the Entry Form on the 2nd page. PLEASE DO NOT ATTACH the first page (class definitions).
- Bring HARD COPIES of entry form and proof of payment to the show in case of any query.
- DO NOT send POP to cell number contact. Proof of payment to be sent WITH the entry/ies.
- The onus is on the Exhibitor/Owner to provide correct details on Entry Forms. Please check the entry form is fully completed with the correct club name and date of show and information for the relevant dog.
- Incorrect entry forms will be returned and will not be processed until it is corrected and returned.
- If the entry does not stipulated the sex of the dog it will be entered as a DOG;
- If no class is stipulated it will be put into OPEN class unless its age dictates in an age restricted class.
- If a dog is not entered into the incorrect class the dog will automatically be put into the relevant age restriction class as per the date of birth on the entry form.
- DO NOT pay for or send entry form without a registration number as it will not be accepted and you will forfeit the fee.
- No refunds will be considered due to any error or incorrect submission of entry form made by either the Owner/Exhibitor or for any withdrawal of an entry once submitted.
- The committee reserves the right to appoint alternative judge/s should the appointed judge not be able to officiate or allocate to another judge should entries.
- All exhibitors are responsible for the control of their dogs at all times and shall be personally liable for any claims which may arise in respect of any injuries which may arise or be caused by their dog/s. The club officials or KUSA may not be held responsible for any injuries which may arise or be caused by exhibitor's dog/s.
- All dogs must be kept on leads at ALL times other than when partaking in any activity in the ring.
- Bitches in Season are allowed but due consideration by handlers to consider other dogs in the ring and surrounds.
- Puppies under 4 months of age are not eligible for exhibition nor are allowed on the grounds or precincts of the show.
- Conditions attracting immediate disqualification are set out in Reg7&31 of Sched3 of the KUSA Constitution.
