- Unless otherwise stated to the contrary, Breeds will be judged in alphabetical order, as listed in Appendix A of Schedule 2 of the KUSA Constitution.
- Dogs incorrectly entered will be placed in the Open Class.
- . No entries marked TAF or RAF will be accepted.
- Exhibitor numbers can be collected from the Show Office before the commencement of the Show.
- The Club reserves the right to appoint alternate judges should any of the above be unable to officiate.
- In terms of Schedule 3, Reg. 5.8.1, please note that puppies under 4 months are not eligible for entry.
- In terms of Reg. 5.10.1 all Exhibits must be present 30 minutes prior to commencement.
- The Show will be conducted under the rules and regulations of the Kennel Union of Southern Africa.
- All exhibitors, handlers & owners are advised that they and any exhibit entered in this event may be photographed for, by or on behalf of WGKC/PETEXPO for use and possible publication.
- Sufficient parking has been provided no vehicles will be allowed within the designated show area. PARKING AT OWNERS RISK.
- Bitches in season will be permitted, but please show consideration. No mating of bitches within the precincts of the grounds permitted.
- Exhibits to be on lead at all times.
- No animal other than an exhibit entered is permitted at the Shows.
- Conditions attracting immediate disqualification may be found in Schedule 3, Regulation. 7 & 31 of the KUSA Constitution.
