In terms of Schedule 3, Reg. 5.8.1, please note that puppies under 4 months are not eligible for entry.

In terms of Reg. 5.10.1 all Exhibits must be present 30 minutes prior to commencement.

Exhibitors / Handlers are responsible for the control of their dogs and shall be personally liable for claims for injuries / damages caused by their dogs.

The Show will be conducted under the rules and regulations of the Kennel Union of Southern Africa.

All exhibitors, handlers & owners are advised that they and any exhibit entered in this event may be photographed for, by or on behalf of WPKC for the use and possible publication.

Sufficient parking has been provided - no vehicles will be allowed within the designated show area. Unhitched trailers will be allowed to be pushed in. PARKING AT OWNERS RISK.

Bitches in Season will be permitted, but please show consideration. No mating of bitches within the precincts of the grounds permitted

Exhibits to be on lead at all times.

No animal other than an exhibit entered is permitted at the show.

Conditions attracting immediate disqualification may be found in Schedule 3, Regulation. 7 & 31 of the KUSA Constitution.

ALL EXHIBITORS/HANDLERS ARE PERSONALLY RESPONSIBLE FOR THE CONTROL OF THEIR DOGS AT ALL TIMES AND SHALL BE PERSONALLY LIABLE FOR ANY CLAIMS WHICH MAY BE MADE IN RESPECT OF INJURIES WHICH MAY ARISE OR BE CAUSED BY THEIR DOGS.
