The committee reserves the right to appoint alternative judges at its discretion.

PLEASE NOTE

Only dogs with a KUSA Registration Number are eligible to enter shows and those dogs which have been given showing clearance from the KUSA office for this show.

ONLY MEMBERS of the Kennel Union shall be entitled to enter dogs in their registered ownership in any Championship Dog Show licensed by the Kennel Union.

Exhibit numbers may be collected from the show office on the first day for all events or prior to the commencement of judging at each show.

Bitches in season are permitted, but exhibitors are requested to show consideration to other exhibitors.
