The mating of bitches within the precincts of the show is forbidden. All dogs are to be kept on leash at all times.

COVID-19 Protocols & Procedures will be observed at this event • A maximum of 2000 people will be allowed at the venue at any one time if held outdoors, or 750 attendees if held indoors. • All persons attending this event must wear a reusable cloth or sponge face mask, or a disposable surgical mask, except when running while handling a dog in competition.
