#### REQUIRED BY KUSA PLEASE TAKE NOTE

Schedule 3, Regulation 16.2: No dog shall be allowed to be off a lead or benching chain unless required by the Judge. Leads may not be longer than 2m – see note to Sch 3 reg 16. Reg 3.5 states that a show starts 2 hours before the scheduled judging time and ends 1 hour after the final event is judged. During this time Reg 16.2 shown above shall apply.

"All exhibitors / handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs."

NO CARS ON THE FIELDS, PLEASE. You may push your trailer onto the field only behind boundary rope.
